



SALEM BICYCLE CLUB'S PEACH OF A CENTURY Sunday, August 25, 2019

WHAT

You choose—a **Full Century** (100 miles), a **Metric Century** (66 miles), or a **76-mile** route. The full century route is challenging with some steep hills. The Metric Century offers flat to rolling terrain with some moderate hills and the extra ten miles on the 76-mile route are hilly. The Peach is open to all bicyclists who agree to **Share the Road** with other users by riding **safely, lawfully, and courteously**. The Peach of a Century is not a race and will proceed rain or shine.

REGISTRATION

Pre-registrations via mail must be postmarked by August 16. Online pre-registrations will be accepted until August 19 at www.salembicycleclub.org. Riders pre-registering may also order a sandwich to be delivered to the Stayton Rest Stop. Sandwiches will **not** be available for purchase on the day of the ride.

Riders' packets will be available at the registration table for those who have pre-registered. **Registration confirmations will not be mailed prior to the ride.** Packet pickup and Day-of-Ride registration opens at 7:30 a.m. and closes at 9:00 a.m. All riders must start by 9:00 a.m. Registration entitles riders to a route map, rider identification, rest stop services, and fantastic peach pie at the finish!

WHAT TO BRING

Choose clothing for all weather conditions that may occur. Also bring a spare tube, patch kit, pump, water bottle and tools for on-the-road repairs. **Each participant must wear a helmet that meets CPSC requirements.**

WHERE

All routes start and end at **Chemeketa Community College** on Lancaster Drive in northeast Salem. From I-5, take the North Salem exit (#258). Go north on Portland Road 0.3 mile to Ward Dr. Turn right and follow Ward Dr 0.6 mile to Lancaster Dr. Turn right and go 0.4 mile. Turn left into the main college parking lot.

Note: The Chemeketa Community College facilities are rented by the Salem Bicycle Club for use during the Peach of a Century. The college is not otherwise involved in the ride, cannot provide additional ride information, and assumes no liability for any losses incurred by participants.

REST STOPS

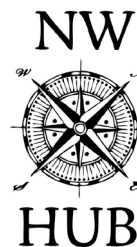
There will be three Rest Stops on the 100-mile route and two on the 66 and 76-mile routes. All Rest Stops will have food, water, sports drink and rest rooms. The first Rest Stop is in Jefferson and will close at 11:30 a.m. The second Rest Stop is in Stayton and will close at 2:30 p.m. The third Rest Stop is in Silverton and will close at 4:30 p.m. All riders must finish by 6:00 p.m. A sag vehicle will sweep both courses at day's end.

DONATION

The Salem Bicycle Club will donate \$1 of each Peach of a Century registration fee to promote cycling and bicycle safety in the community.

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY
AND PARENTAL CONSENT AGREEMENT
("AGREEMENT")

IN CONSIDERATION of being permitted to participate in any way in the SALEM BICYCLE CLUB ("Club") sponsored Bicycling Activities ("Activity") I for myself, my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree and represent that I understand the nature of Bicycling Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further acknowledge that the Activity will be conducted over public roads and facilities open to the public during the Activity and upon which the hazards of traveling are to be expected. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

2. FULLY UNDERSTAND that: (a) BICYCLING ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Activity, the conditions in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS AND DAMAGES I incur as a result of my participation in the Activity.

3. HEREBY RELEASE, DISCHARGE, COVENANT NOT TO SUE, AND AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Club, its administrators, directors, agents, officers, members, volunteers and employees, other participants, any sponsors, advertisers, and, if applicable, owners and leasers of premises on which the Activity take place (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such claim.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
